# From the President's Desk Cathy Elkins Changes in the Air

1. Organizational Changes: Our national organization, Funeral Consumers Alliance, founded in 1963,



has given up their office in Vermont as a cost saving measure. Their Director, Josh Slocum, has resigned and other staff were let go. Their current office address is 629 Paris Street, Graham NC 27253-3222. (Our affiliate, FCACO, was founded in 1953 and was originally called The Memorial Society of the Columbus Area.) Their 6-member Board of Directors is a working board much like our board of directors. Like us, they are a 501 (c) (3) non-profit organization dedicated to educate and advocate consumers' rights and choices in the funeral industry.

2. Changes in the Funeral Rule: The Federal Trade Commission (FTC) in Washington, D.C. has the responsibility to regulate the Funeral Industry. The national FCA and the Consumers Council have lobbied heavily with this Board. Over the years the FTC has made the funeral industry more consumer friendly.

The FTC mandated that funeral homes must give consumers their General Price List to anyone who came in to ask about funeral goods and services. Sixteen items are specifically required to be on the list.

For over a year, the FTC has been reviewing public comments on changes to the rule, including a requirement that funeral homes that have websites post their prices on- line in a consumer-understandable manner. The deadline for comments has been extended to October 10, 2023.

### **Estate Planning: Include Digital Power of Attorney**

Planning for what happens to our assets after we pass has traditionally included a standard list of financial accounts and physical possessions. Today, much of our business and personal lives are conducted electronically, bringing a new category of assets into estate planning. With changing privacy laws, new ways of storing sentimental materials, and even brand-new currencies, digital assets must be considered in the estate planning process.

Digital assets fall into four main categories: 1) electronic items, like Bitcoin, that have actual monetary value, 2) online access to regular financial information like bank and investment accounts, 3) electronic communications which include email accounts and public and private messages in various social media profiles, and 4) all other activities conducted online, including family photos and videos, hobbies, genealogy, and volunteer organizations.

In addition to enabling our executor to pay our electronic debts, most of us would like to provide family and friends with access to photos and videos, stored on our smartphones and other devices, but companies like Apple or Facebook cannot provide the passcode to unlock an account after its user is deceased. In addition to providing access to some people, we may wish to prevent others from gaining access to certain embarrassing or private information.

The Ohio State Bar Association states that "This is a new area of the law and many form wills do not give specific powers for digital assets. Experienced estate planning attorneys can customize estate plans to help their clients address their unique situations and develop comprehensive plans"

### **Indigent Burial in Ohio Cathy Elkins**

The last two Ohio biennial budgets (4 years) provided funds to reimburse Ohio municipalities for the burial or cremation of their indigent residents. The current Ohio Budget, signed by Governor DeWine on July 4, 2023, did not include funds for this purpose. Our board authorized me to write a letter to the Governor asking him to work with the Legislature to replace these funds. I also wrote a letter to the Columbus Dispatch about this. ### What You Need to Know About Embalming

In Ohio, you have the right to refuse embalming when selecting funeral options. There are some exceptions. The health department can require the body of a person who died of a communicable disease to be buried or cremated within 24 hours after death. In some states, bodies transported across state line must be embalmed.
